Dwight D. Eisenhower Middle



Affordable Care Act Cadillac Tax

If you have been following the news for the past 4 or 5 months then you know that Congress on December 18, 2015 passed a delay of the 40 percent excise tax on high-cost employer sponsored health plans, also known as the "Cadillac Tax". This delay was part of a year-end government funding package and changes the effective date from 2018 to 2020. The December 2015 changes make it tax deductible for employers who pay it.


During lunch, several Delegates or their aides joined us and offered encouraging words in regard to pension funding and senior issues.

BYLAW CHANGE

The first reading of this proposed change was at the March meeting. It will be brought to the floor at the May meeting for a vote.

<u>The bylaw currently reads</u>: All retired teachers and other Board of Education personnel who are receiving retirement allowances from the Maryland State Retirement and Pension System are eligible for member-ship upon payment of annual dues.

<u>As amended the bylaw would read</u>, "All retired teachers and other Board of Education personnel who are receiving retirement allowances from the Maryland State Retirement and Pension System are eligible for membership upon payment of annual dues. Membership shall include enrollment as a member of the Maryland Retired School Personnel Association (MRSPA)(effective July 1, 2017) Current local only members before this date shall be allowed to continue as such.

<u>Rationale:</u> It has become more and more apparent that the work of our local association is enhanced by the work done at the state level. This bylaw change would make our bookkeeping more efficient and would give our membership more information about their retirement situations and present them with more benefit options.




SCHOLARSHIPS
