BYLAW ADDITION for VOTE

After our first reading in November, this change will be voted on at our January meeting. It is an addition to allow the board, officially, to hold meetings virtually. The interlined section, in red, is to be deleted, is a requirement to set all meeting dates at the first of the year. The new material, in blue, will make it possible for the organization to allow for unforeseen happenings.

Article II

Members

SECTION 3. Place of Holding Meetings. All meetings of members shall be held at the principal office of the Corporation or elsewhere in Maryland as designated by the Board of Directors. Meetings of the Corporation shall be held on the fourth Wednesday of September, November, January, March, and May. If necessary, the meeting dates may be adiusted at the discretion of the Board of Directors. at its first meeting of the fiscal year. In the event of a national or local emergency, the Board of Directors may authorize holding Executive Committee and/or General meetings virtually or with any similar electronic form of communication. Participation in such meetings shall constitute presence for the purpose of business conducted during those meetings.

Please attend the meeting if you intend to have input and vote on this change.
