PRESIDENT'S MESSAGE

Only our friend, Maryland Senator-Elect Joanne Benson, can talk the way she does. At times preacher-like, politician-like and neighbor-like, Joanne conveyed to our members at our November 18th meeting her clear stand as obligation to fund its employer's share of the pension an advocate for public education, active and retired educators, and the children we teach. As such, we will be counting on her assistance and words of advice as the proposal to transfer the cost of the State Teachers' Retirement & Pension System (STR&PS) to the counties as put forth by Senators Mike Miller (Prince George's & Calvert Cos.) and Richard Madaleno (Montgomery Co.) is debated in the halls of Annapolis.

Please know that through PGPSRA and MRSPA, your interests are being represented. At legislative workshops, committee/ commission hearings and in personal conversations, the message is the same: "The STR&PS is a state program. We, the employees contributed our share PGCPS record. We encourage your presence to hear his of the cost. The legislature needs to stop taking monies statutorily obligated to the STR&PS and begin making up the deficiency it has created."

Recently Senator Madaleno and other legislators have become fond of saying that the money was taken from the TR&PS to fund the Thornton Commission. The facts don't support them. Fact: The 2002 legislature meeting in the winter of 2002 approved Governor Glendening's

taking of \$78 million due to the State Employees' and State Teachers' Retirement and Pension Systems. The very first funding of the Thornton Commission occurred when Governor Ehrlich included it in his FY 2004 state budget. Moreover, taking funds obligated to fund employee and teacher pensions to fund other state programs, regardless of what these programs are, does not relieve the legislature of its long-standing, statutory

LEGISLATIVE REPORT

The Maryland General Assembly convened on January 11, 2011, and will conclude on April 11th. Nearly all of our county's Maryland Senators and Delegates were returned to office. Two moved from delegate to senator positions: Joanne Benson and Victor Ramirez. United States Senators Barbara Mikulski and Ben Cardin, along with Congressional Representatives Steny Hoyer and Donna Edwards, were re-elected. Prince George's County elected a new County Executive, Rushern Baker, and a new County Sheriff, Melvin High.

It is important that we continue to express our firm opposition to the shifting of 50% of the state retirement funding to the local jurisdictions. As we've mentioned before, if counties are forced to pay into the retirement fund, they must cut costs in other ways. We don't want to see our health care benefits reduced or eliminated. In September Governor O'Malley established the Public Employees and Retirees Benefits and Sustainability Commission (as directed by the 2009-2010 Legislature) to study and make recommendations on all aspects of state funded benefits and pensions provided to state employees and teachers. A report from the Commission will be made public in January.

We are eagerly awaiting the Joint Committee on Pensions recommendation regarding a COLA for this coming July. A positive Consumer Price Index (CPI) is expected for the year that ended December 31, 2010. This should mean a slight positive adjustment in our July retirement checks, after compensating for the negative COLA of last year.

Our annual PGPSRA Legislative Day Trip to Annapolis is planned for Wednesday, March 16, 2011. I encourage you to accompany the group to let our legislators know of your concern for our pensions and health care. We will leave the PGCEA office at 8:45 a.m. and return about 2:30 p.m. While in Annapolis, we will sit in on short sessions of both the House and Senate and tour the Governor's Mansion. All of our Prince George's legislators will be invited to join us for an informal sandwich/cookie lunch and to speak briefly to our members in attendance. There is no charge for the trip. Excerpts from President Obama's Message Regarding Recent Health Care Legislation (11 - 22 - 10)

"Over the last few years, many Americans have seen their health insurance premiums skyrocket, while the quality of their health care declined. One of the reasons I pushed so hard to pass health care reform this year was to make sure that American consumers get what they pay for when it comes to health care."

"Today we are launching a new provision of the Affordable Care Act that does exactly that. Next year, insurance companies will be required to spend at least 80 percent of the health insurance premiums you pay on your health care, instead of overhead costs like advertising and executive compensation. If they don't, they will be required to give you a rebate or cut your premiums starting in 2012."

"Here are just a few ways the Affordable Care Act is helping you and your family.

- **HealthCare.gov.** This new website helps you find private health insurance that's right for you and your family and now allows you to compare pricing for the options available to you. In 2014, there will be many more affordable private plan choices.
- Patient's Bill of Rights. Insurance companies can no longer place lifetime limits on your care. If you're a young adult under age 26, you can stay on your parents' plan, and if your child has a pre-existing condition, insurance companies can't deny his or her coverage.

Pre-Existing Insurance Plan. If you have a pre-existing condition and are having a problem finding coverage, the Affordable

• Care Act created a special insurance plan just for you.

Help for Small Businesses. If you're a small business owner, you may be eligible for tax credits to help provide insurance for your employees.

Free Preventive Care. If you are purchasing a new plan, you'll get preventive care like cancer screenings, well-baby and well-child check-ups and blood pressure or diabetes tests for free
