Our committee tries very hard to stay in touch with our scholarship recipients. Amanda Weller and Troiah McCorkle, two of our 2015 recipients, are sharing with us this month.

To the Prince George's County Public Schools Retirees Association,

I would first like to take a moment and thank the association for the scholarship money that I received for this semester and next. This scholarship money has given me the chance to further pursue my dreams of becoming a teacher and I sincerely appreciate the opportunity that has been given to me.

This semester has been one filled with challenges and excitement for me as this is my final year at Towson University. I am currently a senior with a 3.56 GPA studying Middle School Education with a concentration of science and social studies. I am aware that anyone reading this usually pauses to take a look back to make sure they really read Middle School Education, and the answer is yes that is exactly what you read. Without a doubt Middle School is stereotyped as being the most unruly, filled with unbridled adolescent hormones and hourly drama, we have been categorized as the messy middle stuck between elementary and high school. But the truth is, I absolutely love every minute of it. This past semester I have started my internship at Middle River Middle School in Baltimore where I have been given the opportunity to work with some of the finest educators. When I walk into this middle school I know that this day will be nothing like the day before, but I also know that I am walking into a classroom filled with the same faces who are already as eager as I am to see what the day has in store for them.

My internship this semester began with a rotation in science where I worked with two 7th grade GT classes and one standard 8th grade. I was welcomed into this classroom not only by the teacher but the students as well, who were more than open to the idea of helping to teach a future teacher. My first teaching segment was on plants (the roots and vascular tissue), I had stations set up for the students to move into groups where they would have the chance to explore different types of plant roots and tissue. The students were eager to participate and liked the hands on approach that had been provided to them (I have found that middle schoolers love nothing more than to be able to move around). After finishing the stations it was time to discuss plants, having been up the night before studying all there is to know about plants, I was ready for their questions, or so I thought. At this moment, my students taught me a valuable lesson, that no matter how much preparation I have done I still do not know it all. I am still as much a student as they are, and I found that they liked me even more for not knowing their answer.

I have just begun my second rotation in my social studies content, in my next teaching segment I will be introducing the 8th grade GT U.S. History class to the major battles of the American Revolution. With this semester winding down I cannot help but to feel the anticipation building up for next semester when I will be completing my full time internship. I hope that this letter allows the Association to see that the scholarship that has been given to me allowed me to have these experiences that have helped shape me as a future educator. So again I thank you for your generosity in providing me with this scholarship and look forward to the other experiences that are soon to come.

Payroll and Benefits Collaboration Report

The Payroll and Benefits Collaboration Committee met on Monday, November 23, 2015 at the Prince George's County Board of Education.

- We were informed that the Fall 2015 Pre-Retirement Planning Conference was held October 31st at Wise High School. There were 267 attendees, 60% plan to retire within the next 3 years. The next Pre-Retirement Conference will be held in the spring. Please let your friends, who plan to retire, know that Retirement Coordinators are available at the Board and are assigned by location. Moreover, let them know that the Benefits Office Retirement Coordinators are available to help them through the process and can be contacted by calling the Payroll and Benefits Office at 301-952-6200
- Open Enrollment was held this year between October 26th and November 20th. There was more action from active employers. Remember, open enrollment is a time when retirees, too, if they so desire, can make medical insurance changes. Important: If you have lost your spouse or divorced your spouse and still carrying them on your health insurance --- you need to notify the Payroll and Benefits Office as soon as possible; these changes are not restricted by open enrollment.
- Medicare If you are a retiree of the Prince George's County Public School System, 65 or older, and receive your health insurance through the System and not receiving Medicare, you will be receiving a letter from the Benefits Office in December. It is now required that you complete the necessary forms for Medicare.

Legislative Report September 2015

Legislative Workshop on November 4th

MRSPA President Max Muller greeted us and told us that retirement benefits and health care will continue to be important issues during this coming Legislative session. Tish Raff reminded us to contact representatives and to stay informed. R. Dean Kenderdine, director of the state retirement and pension system, reviewed the actuarial funding system and its growth.

Deputy Chief of the consumer protection division of the Attorney General's office, Steve Sakamoto-Wengel, spoke at length about consumer protection. The consumer guide for Marylanders is on order. This covers consumer scams, health issues and financial matters. Oag.state.md.us You can view the booklet on line.

Delegate Eric Ebersole spoke about Education issues including charter schools and tax breaks for private schools. AARP's Tammy Bresnahan encouraged our participation in upcoming bills including secure choice, a retirement plan for employees in a small business, the care act, which assures support and training for at home caregivers and utility rates.

We will be going to Annapolis on Thursday March 10, 2016 for our own Legislative day. Depart PGCEA at 8:45 AM and return by 2:30 PM. Our agenda includes an introduction, sitting in on House and Senate sessions, Governor Mansion visit, lunch and greetings from several legislators.
