LEGISLATIVE REPORT

Our annual PGPSRA Legislative Day in Annapolis is scheduled for Wednesday, March 16, 2011. Please come and be a part of the group that will travel to Annapolis by coach bus for this event, sponsored by Delegate James Proctor (27th District). We will be leaving the PGCEA office in Forestville at 8:45 a.m. and returning about 2:30 p.m. We will sit in on short sessions of the House and Senate and visit the Governor's Mansion. All of our Prince George's legislators will be invited to join us for a sandwich/cookie luncheon and to speak briefly to our members in attendance. You will be representing your co-retirees.

The Maryland General Assembly convened on January 12th and will conclude on April 11th. As you may remember, Maryland was facing a \$1.6 billion budget deficit as of January 1, 2011. The General Assembly has been looking for ways to conquer this deficit. Tax increases on alcohol and gasoline are among other proposals.

The Pension Sustainability Committee met during the fall and made suggestions as to where cuts could be made to help Maryland operate within a balanced budget in the coming year. Fortunately, one of the recommendations, freezing future COLA increases, has been taken off the table. However, the suggestion to shift part of the funding of the pension costs to the local jurisdictions looms large. There have been several suggestions made for active and newly hired teachers in order to keep their current retirement benefits. All involve added payroll contributions and years of service. The Maryland State Retirement Agency reported a superb 18-month investment performance from July 1, 2008, through December 31, 2010, raising the assets of the system to \$36 billion --- an increase of more than \$4 billion. These positive changes will not be reflected in our state's economy, though, before 2012 – 13. In order to have our retirement system properly funded, the General Assembly needs to consider the Board of Trustees' request to begin pulling out of the Corridor Funding method and revert to the Actuarial method of funding.

Good news, the end of year Consumer Price Index CPI) determines the annual Cost of Living Allowance COLA) for us. A report out on January 14th noted that the 2010 CPI was at 1.5%. Our July retirement/pension checks will show a COLA of 1.284%, following the deduction of last year's COLA, when the CPI dipped below one percent to .356%.

It is important to contact your legislators individually on the shifting of funding to the counties issue by writing letters, and/or e-mails, telephoning, and speaking in person. Let your voice be heard! As we go to press, members of PGPSRA plan to join me at the Miller Senate Building in Annapolis on February 16th, to go to all of our Prince George's legislators' offices, to let them know we are retired school employees who strongly object to shifting any portion of the funding of our retirement/pension system to the county. Less county funds could adversely affect our health care benefits. On January 19th, President Carl Lancaster and I visited the thirtytwo Prince George's legislators' offices and left a letter telling of our concerns. We were well received.

Unfortunately, the United Seniors of Maryland Rally, planned for January 25, had to be changed to March 9, 2011. Please contact me for a ticket if you plan to attend this informative event.

Watch out for this scam!

One of our members called in to report a scam pulled on her father and some of his neighbors. A gentleman in a uniform and hard hat, holding a clipboard, knocks on the door and says there is a gas leak or other utility problem in the neighborhood, and he needs to check your basement or utility room. While you are taking him there to examine the area and receiving the good news that everything is fine, an accomplice has come in through the now unlocked door and scanned your home for cash, wallets, or purses left out, along with any jewelry or small electronic items that can be quickly filched. They are long gone before you even know you've been burgled. Don't fall for this. Always ask to see an ID card, and examine it carefully. Telephone the utility in question if you have any doubts.
