PRESIDENT'S MESSAGE

You may recall that in the January *ECHOES* I discussed the myriad activities occurring within the PGPSRA. Let me assure you that PGPSRA's activity level has not lessened in the least. The Community Service Committee continues to work to assist children in several schools with certain articles of clothing and with school supplies. The Scholarship Committee recently has contacted and delivered information about PGPSRA's Scholarship Program to the guidance office in all of our high schools. If I recall correctly, there will be at least six scholarships of \$2,000 each awarded later this spring. If you have not yet contributed to the Scholarship Fund, it is not too late. This article deals with the governor's announcement that he is going to ask the legislature to approve an "unprecedented tax increase on gasoline," a 6 percent sales tax on every gallon of gasoline sold in Maryland. At current prices, approximately \$3.45 per gallon, that would add some \$.20 - \$.21 to the price of every gallon purchased.

All of these initiatives, if enacted, will have deep and LONG LASTING impact on both active and retired educators. If you're not up-to-date on what's happening, read the newspapers daily, come to our meetings or simply pick up the phone or drop us a line.

On Monday, January 16, Jannette Wundrow, Sue Finan and I visited the legislative offices of all Prince George's County legislators and also met with the House Delegation Chairwoman, Melony Griffith. In previous sessions our county's House delegation has stood firm in opposition to Senate President Thomas V. Mike Miller's efforts to shift one-half of the state's contribution for teacher pensions onto the counties. Jannette, Sue and I are hopeful that under Delegate Griffith's leadership, our delegation will continue to protect the counties from being burdened with what rightly always has been the state's responsibility.

as Treasurer, a former member of the House of Delegates for twenty-nine years, Chairwoman of the Board of Trustees for Maryland's Retirement and Pension Systems and as Chairwoman of the Maryland College Savings Plan. She very graciously spent an hour with us and everyone was impressed by her calm, gracious manner and her willingness to take questions from the attendees.

Lew Robinson, the Executive Director of PGCEA was our second speaker on January 18. On October 20th, 2011, Lew was a recipient of a Civic Leadership Award by the Community Foundation of Prince George's County – one of only three awards presented last year. Last June 30th, Lew completed twenty years as the Executive Director of PGCEA. In addition, Lew serves on the Maryland College Savings Plan Board of Directors with Treasurer Kopp. It was an honor to be able to recognize his many contributions to our school system and all of its employees and to have Treasurer Kopp share in the moment.

The article details the challenges he faces on a number of key budget and tax proposals in this year's legislative session. There are numerous issues on the governor's very large plate: same-sex marriage, broad-based tax increases, doubling the charges for the so-called "flush tax"; a plan ultimately to shift half of the state's contributions for teacher pensions onto the local counties, a plan to initiate an offshore windpower industry in Maryland, and last but by no means least, his plan to increase the state's tax on gasoline.



On Friday, January 27, Jannette Wundrow and I attended the weekly Prince George's House Delegation meeting in Annapolis and had a chance to speak very briefly with a number of our delegates before the meeting began. As it turned out, Dr. William Hite, Superintendent of Schools for PGCPS presented his status report on the school system. He addressed the financial challenges that confront our school system and efforts being made by the County Executive, members of the County Council and state legislators to do what they can to improve the funding and to oppose placing the responsibility for teacher pensions on the counties. Dr. Hite addressed the status of numerous initiatives being implemented to improve education for all the children. Previously, you may recall my describing the new Health Services program that began at the Prince George's Community College last fall with an enrollment of 100 ninth graders. Dr. Hite reported to the House Delegation that 50% of the 100 ninth graders came from homes below the On a more state-wide basis, I refer each of you to an article poverty line and that at the end of the first semester no student had dropped out of the program, the 100 students had an overall GPA of 3.78 and there is a waiting list of more than 4,000 students wanting to get in to this coming fall's second class of ninth graders. Dr. Hite's presentation was extremely positive and I cannot tell you how impressed I am with his leadership skills and the positive image he projects. He seems always to have a calm, quiet command of the situation at-hand and I believe we are very fortunate to have Dr. Hite as our Superintendent!

LEGISLATIVE REPORT

The Maryland General Assembly has been in session since January 11, 2012. Governor O'Malley has stated that his areas of concentration during this session will be education and transportation. His proposed budget includes many tax increases, along with some shifting of the pension funding to local jurisdictions. MRSPA's Legislative Committee plans to meet with the governor to discuss the likely consequences the pension shifting action could have on our county retirees and their health benefits. The budget will not be finalized until April 3, 2012.

It is important that we continue to ask our legislators NOT to shift the pension funding to the counties, and NOT to reduce the COLA formula for retirees, and to return the Maryland State Pension System from the Corridor Funding to the Full Actuarial Funding Method. President Carl Lancaster, Sue Finan, and I went to Annapolis on January 16, 2012, to hand-deliver letters with the above message to each of our Prince George's legislators. We also met with Delegate Melony Griffith, Chair of the Special Joint Committee on Pensions. Each Friday morning I, and often Carl Lancaster, attend the Prince George's Legislative Caucus to hear of specific plans for legislation within the county.

The United Seniors of Maryland (USM) held their Legislative Forum Day on January 24, 2012, at St. Johns College in Annapolis. We heard speakers Senator Minority Whip E. J. Pipkin, House Speaker Micheal Busch, House Minority Leader Anthony McDonnell, and Secretary of Aging Gloria Lawlah. Everyone spoke of Governor O'Malley's proposed budget cuts and added taxes. During a one-hour segment of the meeting, attendees from each county represented met with their local legislators to discuss current issues before the General Assembly. Our Prince George's legislators voiced their support of NOT shifting the pension funding to the local jurisdictions. Attending from PGPSRA were Bonnie Brose, Sue Finan, Oliver Myers, and myself.

Our annual PGPSRA Legislative Day in Annapolis will be March 14, 2012, sponsored by Delegate James Proctor of the 27th District. Please plan to join the group, as we will be representing all county school employees with our pension and COLA concerns. We will be leaving the PGCEA office at 8:45 a.m. and travelling by coach bus to Annapolis. There we will

sit in on short legislative sessions of the House and Senate, tour the Governor's Mansion and Historic Rooms and Chambers of the Maryland State House, and enjoy a sandwich/cookie lunch, during which all of our county legislators are invited to join us and speak briefly. We will return to Forestville about 2:30 p.m. There is no cost for this special day in Annapolis.

Do you know?

Maryland Motor Vehicle Administration (MVA) recently announced it has added an emergency contact option to Maryland driver's licenses.

Maryland drivers can now add up to three emergency contacts to their driver's license so police will know whom to call if an accident occurs. The emergency contact information is stored electronically on an individual's driver's license and will be available only to authorized personnel.

You can go to the MVA's website at www.mva.maryland.gov and add three emergency contacts in just a few minutes. You will need to have your driver's license number. Go to the website, on the right find "Do it Online" and there you will see the choice and click "Emergency Contacts" and in the next menu again click on "Emergency Contacts" to add your emergency contacts. The entire process takes less than ten minutes.
