#### LEGISLATIVE COMMITTEE

#### Legislative Report March 2021

On January 26, 2021 George Denny, Norma Martof and I attended the MRSPA Legislative Day via Zoom. MRSPA President George Denny, opened the meeting at 10:00. Our first speaker was R. Dean Kenderdine director of the Maryland State Retirement and Pension System. Mr. Kenderdine spoke about the strength of the pension fund. At this time, the system is 72.9% funded with monies coming from employer and employee contributions as well as long term investments totaling close to 61 million dollars. The pandemic has had no financial impact on the fund. At this time, the Governor's budget has been submitted and is set to pay in full the contribution rate certified in November 2020.

Mr. Kenderdine encouraged members to register with the SRPS to review your personal retirement information. The web site is mysrpsusers.sra.maryland.gov

Tammy Bresnahan, AARP representative, reported on the AARP 2021 Legislative priorities with strengthening regulations and certification of staff in assisted living facilities as one important goal. Other goals include paid family and medical leave, the regulation of prescription drug cost and overall improvement of internet access for all. Discussion included testimony from two members about their heart wrenching experiences with loved ones in assisted care during the COVID-19 pandemic.

Rebecca Ruff from the Maryland budget office noted that MD received 30 billion dollars in COVID-19 relief funds and that the fiscal budget seems to be reasonable.

MRSPA's Virginia Crespo encourages members to visit the MRSPA website to view the Legislative priorities and to stay fully informed.

# RESERVATIONS FOR MARCH


Our March 24 General Membership meeting will be held virtually, again. We have done quite well with these and hope to have many of you able to join us for this one.
