#### PRESIDENT'S MESSAGE

Through the personal involvement of its members, the Prince George's Public School Retirees Association has been actively engaged in a number of important activities during the 2010 - 2011 membership year.

Continuing to perform at an outstanding level, the Community Services Committee conducted successful coat drives and shoe drives for youngsters in need of these articles of clothing.

PGPSRA's Scholarship Committee will be awarding over \$13,000 in scholarships to at least six students later this spring.

The ECHOES newsletter has provided current information to members every other month in a clear, easily understood format.

PGPSRA has had an ongoing presence in Annapolis during this year's legislative session. The Board of Directors, at its meeting in June 2010, adopted "an enhanced presence and involvement with the legislature" as a goal for this year. Included in the association's activities calendar for this year were visits to Prince George's County legislators' offices in January, February and March, 2011. Most recently, thirty-five of our members spent about one-half day on March 16 in

#### LEGISLATIVE REPORT

Special thanks go to thirty-four PGPSRA members who participated in our annual Legislative Day in Annapolis on Wednesday, March 16, 2011. We were recognized from the floor of the House and Senate. Seven of our Prince George's County legislators and six aides representing other legislators, along with County Executive Rushern Baker, stopped by during lunch to speak briefly with our members in attendance. Delegate James Proctor of District 27, who is also a member of our organization, sponsored this trip for us. Senator Mike Miller arranged for his personal photographer to take a photo of everyone on the State House steps.

The Maryland General assembly concluded on April 11th. As you may remember, Maryland was facing a \$1.6 billion budget deficit as of January 1, 2011. The General Assembly was looking for ways to conquer this deficit. Deep cuts in education were proposed, as well as increased taxes on gasoline and alcohol. The suggestion to shift part of the funding of pension costs to the counties is still a prominent topic. There were several suggestions made for active and newly hired teachers in order for them to keep their current retirement benefits. All involved added payroll contributions and years of service. Unfortunately, because Prince George's County will receive considerably fewer dollars from the state in their 2012 budget, many educational staff positions will be eliminated. The federal government also played a part in the county's education budget by eliminating funding for

Annapolis.

From time-to-time, the General Membership Meetings are used to educate the members on important and relevant topics. The main presentation at the March 23rd meeting dealt with "Eldercare" and a wealth of valuable information was reviewed with those in attendance.

PGPSRA has continued to support the school system at the fall and spring Pre-Retirement Seminars. Our volunteers briefly interacted with the attendees, distributed MRSPA and PGPSRA literature, and urged the attendees to join our organizations.

PGPSRA will be winding up this year with its traditional membership meeting at La Fontaine Bleu on May 25. Be sure to sign up to attend; details are in a separate article.

### **Eldercare: Pitfalls and Options**

Guest speakers at the general membership meeting on March 23, 2011, were former Senator Gloria Lawlah, Secretary of Maryland Department of Aging, and Alice Hedt, of the Maryland Long Term Care Ombudsman Program.

Secretary Lawlah, a former Prince George's County educator, listed the following things to do before becoming ill or incapacitated:

- 1. Name a Power of Attorney.
- 2. Devise a will.
- 3. Devise a living will.
- 4. Have the documents notarized and registered with the county Register of Wills.
- 5. Share copies with family, friend, minister, doctor.

This is especially important for persons with no family and those who live alone.

Programs in planning for Maryland seniors are as follows:

- Dental care for seniors
- Use of wrap-around services for in-home care vs. nursing home
