LEGISLATIVE REPORT

Although we, MRSPA, along with all Maryland county school superintendents, county executives, MSEA, AARP advocates, and numerous other people across the state, made our concerns known to all of our Maryland legislators about **NOT** shifting the pension funding to the counties, unfortunately, this is exactly what is going to happen. The debate to be reconciled (as of this printing on April 4th) is that the Senate wants the counties to assume the cost of pensions at a rate of 25% for each of the next four years, while the House wants the rate set higher and to be completed in three years. This will mean that the counties will continue to pay 100% of the Social Security contributions for school employees and the teacher pension costs. It is interesting to note that the pension funding is only 4% of the state budget. It is also interesting that **ONLY** the teachers were mentioned by legislators in the pension shifting. It includes all Maryland county librarians and professors at all community colleges.

The Maryland State Retirement/Pension System is showing a recovery since the recession, having gained \$200 million in assets since January 1st. Our retirement checks will continue to arrive on time.

The Maintenance of Effort Bill requiring the counties to meet their obligations to fully fund education did pass. This builds on the Thornton Act. Counties will be held accountable, or face a state penalty. If a county should not put the required amount of money into their education budget, the state will withhold the required amount from the county's income tax and send it directly to the county Board of Education. Quality education in Maryland is a priority!

Special thanks to everyone who attended our annual PGPSRA Legislative Day Trip to Annapolis on March 14, 2012, sponsored by Delegate James Proctor. We were recognized from our gallery seats in both the House and Senate. During the last Prince George's Delegation Caucus meeting of the session (all of which President Carl Lancaster, Sue Finan, and I attended), we were thanked and applauded for the invitation extended to the Delegation to attend our PGPSRA Legislation Day luncheon. For a complete explanation of how the proposed National Health Care Law will affect seniors beginning in 2014, go to your computer and type in AARP Health Care Guide.
