don't want to see our health care benefits reduced, or eliminated. In September Governor O'Malley established the Public Employees' and Retirees' Benefits and Sustainability Commission (as directed by the 2009-2010 Legislature) to study and make recommendations on all aspects of state funded benefits and pensions provided to state employees and teachers. A report from the commission is due in December.

Frightening things are happening across the country with pensions. Illinois and Missouri recently changed their teacher retirement age to 67. Minnesota teachers took a cut in pay, the Governors of New Jersey and California have proposed pension and health care cuts, and several states, including Maryland, had no COLAs or step increases in pay this year. A number of states are looking at having their beginning teachers enroll in a 401K, or similar fund, instead of being a part of a state retirement system. Other states are promoting Defined Contribution retirement funds, rather than the Defined Benefit retirement system, as we have in Maryland. Unfortunately, Defined Contribution funds and 401K funds shift in value

There are fourteen states in which teachers do not pay social security. We are fortunate in Maryland to be able to collect both social security and our retirement/pension checks --- and, to retire before we are 67!

It is with pleasure that we announce Charles (Charley) Lingo Hudson of Silver Spring, as our county winner of the Maryland Senior Citizens Hall of Fame Award for 2010. He was honored, as such, at a luncheon at Michael's 8th Avenue in Glen Burnie, MD. on October 21, 2010.

Charley is a retired Prince George's County teacher and principal (of 35 years), who has served on the Prince George's County Public School Retirees Association Board of Directors for 24 years, and as the group's enthusiastic and capable Tour Director for 18 years. He continues to arrange day trips to theaters for our members several times a year. Charley also holds membership in the Maryland Retired School Personnel Association.

For over 42 years, Charley has been an involved member of Forestville Memorial United Methodist Church in Forestville, MD, where he continues as a lay minister and Sunday School teacher. He has served as President of the Men's Club for the past 20 years. He has been an active member of the social group "Young At Heart" for many years, and is currently serving as their Treasurer. Often Charley drives people needing a ride to church, or related social activities.
