

Hospital Patient's Bill of Rights Goes into Effect for all Marylanders

New Law will provide consumer protection for Maryland hospital patients

A landmark Hospital Patient's Bill of Rights that swept through the Maryland General Assembly in a unanimous vote last spring will go into effect October 1. The new law guarantees that all hospital patients—whether admitted, in ER or outpatient—will receive a list of their 24 legal rights. These rights will provide additional protection for hospital patients, who are some of the most vulnerable consumers.

"Patients will need to ensure they get a copy of their rights when they enter a hospital and that those rights are honored," said Palmisano. "Forward-looking hospitals such as Frederick Memorial Hospital are already well-prepared for implementation, and we look forward to productive discussions with other hospitals."


