LEGISLATIVE REPORT

The Maryland General Assembly convened on January 11, and will run through April 12, 2006.

We are planning our annual PGPSRA Legislative Day in Annapolis on Wednesday, March 15th. This trip is free to our members. We will leave by coach bus from the PGCEA office parking lot at 8:45 am, and return about 2:45 pm. During this trip you will be able to observe our Maryland Legislature in action, tour the State House and Governor's Mansion, and interact with some county legislators during a sandwich/cookie luncheon. Come and join us for an interesting day! (Call: 301-390-7324).

The MRTA Legislative Committee plans to resubmit two bills this coming legislative session: (1) forbidding local boards of education to eliminate retiree health benefits, and requiring them to discuss those benefits with a local association of retirees. (2) requiring counties to count total Maryland service credit in determining retiree health benefits. Delegate James Proctor of Prince George's County (District 27) is sponsoring a new bill for us. It will build on a bill that Delegate Proctor got passed in 2002, which allows a retiree of the MD Retirement and Pension Systems who selects the Option 5 or 6 retirement allowance, to designate a new beneficiary if the retiree's original beneficiary has predeceased the retiree, or if the retiree does not choose a new beneficiary, to have his, or her, retirement benefits "pop up" to what they would have been had no beneficiary originally been named. This newly proposed bill would let retires who choose Option 2 or 3 have the same possibility of a "pop up" if their beneficiary predeceases them and they opt to name no new beneficiary. **Please call your legislators to request support for these bills.


The annual United Seniors of Maryland Rally was held at St John's College in Annapolis, January 24th. Topics of discussion included the restoration of funding for senior programs, long term care (in your home, or another setting), Medicaid funding, and affordable prescription drugs. Speakers for the day included Governor Ehrlich, Senator Mike Miller, Delegate Michael Busch, Department of Aging personnel, and several of our Prince George' Delegates.

Members of your Legislative Committee have been attending the Department of Aging Budget Hearings that are setting spending limits and increases for Meals on Wheels, senior centers, congregate Housing, and the Medicaid Waiver Program across Maryland.

Designated Legislative Committee members have also been attending the Coalition for Pension Fairness Forum, headed by MSTA. We are offering support for a change in the pension system that will enhance the pensions of our current teachers, although it will not change the benefits for those already retired.
