#### LEGISLATIVE UPDATE

The 2004 Maryland General Assembly Session ended at midnight on April 12<sup>th</sup>. A 2005 balanced budget was established, but funding sources for parts of it remain questionable. The Governor remained firm about not raising the sales tax, but he agreed to establish some "user fees".

The slot machine gambling bill failed for the second year in a row, causing Governor Ehrlich to say that without this anticipated revenue, Maryland is going to be short-changed in services. However, studies have shown that Delaware and West Virginia collect only about 1/3 the amount of money in yearly gambling revenue that the Governor has estimated Maryland could receive. Concerns of our lawmakers were the locations and ownerships of the video lottery terminals. Also, the resulting potential for creating gambling addicts and their necessary treatment for various related services (gambling, family counseling, bankruptcy, etc.) would put a strain on our county budget.

A very good thing to come out of this legislative session is the Governor's plan for cleaning up the Chesapeake bay. This is to be accomplished through a "user fee" (jokingly called a flush tax), as each homeowner in the state will be assessed \$2.50 monthly to finance the modernization of wastewater treatment plants.

Another "user fee" to be shared by all citizens is the motor vehicle registration cost increase by 87 percent. This revenue will be used by the state's transportation department.

The Thornton Plan, created to equalize education spending in the state's 24 school districts, received full funding for the coming year, but the Governor feels this cannot happen in the following years without an increase in state income.

Unfortunately, the House and Senate Bills that our Maryland Retired Teachers Association championed, with support from MSTA, AARP Maryland, USM, and NARFE were defeated. They had sought to prevent boards of education eliminating retiree health care benefits, require the boards to discuss health care benefits with local retiree associations, and give persons who move to other counties within the state credit for their full Maryland service when it comes to retiree health benefits. (\*With some rewording, our MRTA Legislative Committee plans to submit these bills again next year, as we feel they are very important to our members future retiree health benefits.)


## 2005 FLORIDA LUNCHEON AND CRUISE 18<sup>TH</sup> ANNUAL REUNION

#### **PGCRTA INCORPORATION**

For the past several years, the topic of incorporating has been discussed by the PGCRTA Executive Board. The topic was frequently brought up as we were going through the process of changing our organization's name. Now that our name has been voted on and officially changed (official as of July 1, 2004), it was decided to pursue the process of becoming incorporated. The primary benefit of incorporating is to protect personal assets from potential liabilities. By forming a corporation and following all corporate formalities, you become insulated from personal liability.

Another advantage is the potential tax advantages to operating through a corporation.

A committee was formed of PGCRTA Board members. A lawyer, John P. Davey, specializing in this area of law was found. The committee and Mr. Davey have met on New BYLAWS have been written two occasions. adhering to the Maryland state incorporation laws. These new BYLAWS include all the points of our current BYLAWS but also have the legal terms and conditions stated that are necessary for a corporation. committee is reviewing these BYLAWS, and will present them to the Executive Board in May. When they are approved by that group, the new BYLAWS will be printed and mailed to every member of PGCRTA (now PGPSRA). A vote will be needed from the membership After that the lawyer submits to the at that point. government various documents including the new \*BYLAWS, our 501 (C)(3) tax code designation, and any other pertinent information necessary, to continue and complete the process of becoming incorporated.

### RECIPES

(From the March meeting)

Lime Jello Salad

1 large lime Jello
water plus pineapple juice
1 large cream cheese - soft
1 -20 oz crushed pineapple
½ cup celery -chopped small
½ cup maraschino cherries -halved
1 small can evaporated milk -chilled \*
Whip until thick, add cream cheese,
blend balance of ingredients
Add ½ cup chopped pecans

\*Put milk in a bowl and place it in the freezer, let chill, whip when thick

Pour into mold. 8-10 servings

#### Hot Chicken Salad

2 c cooked diced chicken
1 can cream of chicken soup
½ can (soup can) water
½ c diced celery
1 small onion, diced
1 can water chestnuts, drained
1 4 oz bag sliced almonds
1 -2 oz jar pimentos
1 -16 oz can English peas
or (16 oz bag frozen petite green peas)
½ tsp salt
½ tsp pepper
1/4 c grated cheddar cheese
1 can (small) chow mein noodles

Drain chestnuts and pimentos (also peas, if canned). Dice celery and onion. Combine all ingredients except cheese and noodles. Spread in 13 x 9 pan. Sprinkle with cheese. Bake 350 degrees, 30-40 minutes, till hot through. Sprinkle noodles on top right before serving. 6-8 servings
