Email these ladies....they will welcome your interest!!


#### **TRIPS**

#### LEGISLATIVE REPORT

According to MRSPA, the Maryland Retirement Trust Fund gained 14.37 percent on investments in fiscal year 2014, which ended June 30, leaving the fund with a total market value of assets at \$45.4 billion, the highest it has ever been. The returns were nearly double our actuarial expected rate of return of 7.7 percent.

Every year, the MRSPA Legislative Committee holds a workshop in Annapolis. This year the date is Thursday, November 13. We will hear about election results and brought up to date on federal and state issues. If you are interested in attending, the cost is \$18. Please send an email to me for further information.
