PRESIDENT'S MESSAGE

It is an honor and a privilege to assume the Presidency of the Prince George's County Retired Teachers' Association for the coming year. Your participation and support of our organization will be greatly welcomed as the year progresses.

Our PGCRTA had it's beginning when a group of nine retired teachers came together for socialization and discussion of their retirement concerns on June 18, 1964 -50 years ago this coming June. The group met at the home of Mrs. Anita Brooks, who was named President, and remained in that office until 1972. With the adoption of a Constitution and By-Laws, on January 26, 1972, PGCRTA was officially established. Our membership has increased steadily, and currently stands at 1700. We became a part of MRTA in 1972, and continue to work closely with our state colleagues on state committees and issues.

It is important that as retired school system employees, we retain our support of PGCRTA for the same reasons that our organization was established: socialization and to voice our concerns about retirement. We do this by coming together for luncheon meetings five times each year, publishing and communicating through our ECHOES newsletter, through established committees that meet and act year-round, and having an elected Board of Directors who conduct the day to day business of the organization.

As an extension of our school and social interests, PGCRTA continues to promote education by giving five \$1000.00 scholarships to college-bound high school graduates, along with smaller contributions to the school system and community throughout the year. We also encourage student mentoring and working with children in other volunteer venues.

So as you can see, we have a vital, involved organization of which you can be proud!

LEGISLATION UPDATE

We are happy to report that on May 22, 2003, Delegate James Proctor and Jannette Wundrow witnessed the signing by Governor Ehrlich, of the companion House and Senate Bills that will guarantee a retired teacher representative on the Board of Trustees of the Maryland State Pension and Retirement System! This is a goal that the MRTA Legislative Committee has worked toward for the past two years, and we are pleased, with the help of Delegate Proctor leading the way and gathering support from other county legislators, that this is now a reality. As you are aware, we currently have a retiree representative on the Board, our own Carl Lancaster, but this is only by coincidence, as Carl was an active teacher when first elected. We are pleased to note that Carl was recently reelected, and will continue to represent retired teachers' interests on the Board for the next four years.

We continue to monitor the Hearings in Annapolis and Washington on Medicare and Medicaid.


